Thank you to all the governors who gave up their time to come and be part of the inspiring governor conference at the Corn Exchange in Devizes. It was great to get so many governors together to hear some key messages about Education and to understand more about the context of the local and national educational picture. Knowing the big picture context supports governors in all the 3 core functions of governance, especially with understanding your context and then setting the strategic direction of your school. In the morning the conference highlighted key areas of change e.g. the new Ofsted framework and questioned our understanding of Inclusion. The afternoon sessions allowed for a more personalised approach and upskill in other crucial areas such as assessment and data; and Maths and English monitoring. A big thank you is extended to all our Keynote speakers and to all the leaders of the sessions in the afternoon. To access Right Choice:

- Log onto the website: <u>http://rightchoice.wiltshire.gov.uk/</u>
- Your username is your Governor email address
- click on 'forgotten Password' to be sent a temporary password to complete the login process

Click the green register button to submit your application for approval.

Approval is not immediate - and you must wait for email confirmation of approval. It can take time to receive this email, particularly if your application is submitted over a weekend or in the evening.

Your confirmation email will be sent to you. Once you receive your email confirmation, which includes your login details, you can login to Learning Link and start to use it whenever you want to.

# Schools Financial Value Standard (SFVS) 2019/20 - changed format

It is a mandatory requirement for LA maintained schools to complete and submit the SFVS to the local Authority by the 31st March each year.

The schools financial value standard (SFVS) helps to provide schools with assurance that they are meeting the basic standards necessary to achieve a good level of financial health and resource management. It can be used to identify possible areas for change to ensure that resources are being used to support high-quality teaching and the best education outcomes for pupils.

#### The Checklist

The checklist asks twenty-nine questions over seven areas:

- Governance
- School Strategy
- Setting the Annual Budget
- Staffing
- Value for Money
- Protecting Public Money
- SFVS dashboard

# **Careers Hub update**

**The Swindon and Wiltshire Careers Hub** is currently working with 58 institutions across the region, 35 of which are in the Wiltshire area, to support Career Leaders to develop their provision for young people in terms of careers and information advice and guidance. Additionally, the Careers Hub is ensuring that all young people have effective encounters with employers and employees and meaningful experiments of the workplace. All schools and colleges are working towards the <u>Gatsby Benchmarks</u>, a framework of 8 guidelines that define the best careers provision in schools and colleges.

Governing Boards have a key role in ensuring schools not only meet their legal requirements, but also equip pupils with the tools and knowledge to make informed choices about their futures. They can do this by offering strategic support to school leaders and by holding the executive leader to account for the quality of the institution's career guidance, information and education. The Careers and Enterprise Company has updated its

<u>*Guide for Governors*</u> to help them support the Careers Leader in their school and ensure the establishment complies with its statutory requirements. The updated guide now also includes challenging questions for the Senior Leaders around each benchmark.

# Important Inspection Data Summary Report (IDSR) reminder from Ofsted

As it is the time of year to be reviewing our current IDSR (released in November), we wanted to draw your attention to the fact that historic IDSRs will be removed from the DfE's Analyse School Performance (ASP).

Any users wishing to keep a copy of their historic IDSRs are advised to download and save their IDSRs before they are removed later in **November**. This does not affect your latest (2019) IDSR. This will coincide with the provisional 2019 **secondary** IDSR release.
